## PROMOTIONAL ACTION REGULATIONS ADDITIONAL 10% DISCOUNT ON SHOES AND TEXTILES WITH PURCHASES OF AT LEAST 149 PLN (applies to Outlet stores and online shop)

### 1. General Provisions

- 1.1. The organizer of the "ADDITIONAL 10% DISCOUNT ON SHOES AND TEXTILES WITH PURCHASES OF AT LEAST 149 PLN" promotion ("Promotion") is OCHNIK S.A. located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399
- **1.2.** As part of the Promotion, the customer will receive a 10% discount on all products when purchasing textiles and shoes for a minimum of 149 PLN.
- 1.3. The Promotion is valid only in Outlet stores and the online store <u>www.ochnik.uk</u>. In the online store, products covered by the promotion will be marked: "Additional -10% on textiles and shoes."

### 2. Participants, Place, and Duration of the Promotion

- **2.1.** The Promotion covers OCHNIK outlet stores and the online store www.ochnik.uk.
- 2.2. The Promotion starts on 04.07.2024 and lasts until further notice.

#### 3. Conditions and Rules of Participation in the Promotion

- **3.1.** The additional 10% discount applies to all shoes and textiles, excluding the Spring-Summer 24 collection.
- **3.2.** To receive the 10% discount, a purchase of products worth at least 149 PLN on one receipt is required.
- **3.3.** The 10% discount is calculated from the current price.
- **3.4.** The Promotion cannot be combined with other promotions or the 10% discount for OCHNIK Customer Club membership.
- **3.5.** Products purchased with a discount from the Promotion can be exchanged within 30 days from the next day after purchase, provided they have not been used and have the

original tags attached. Additionally, the fiscal receipt must be attached to the exchanged product.

- **3.6.** Product exchanges can be made at any regular OCHNIK store.
- **3.7.** After the Promotion ends, products purchased with a 10% discount can be exchanged at the promotional price.
- **3.8.** Products purchased in the Promotion at stationary stores can be returned under the following conditions:
  - If the product is returned within 7 calendar days from the next day after purchase, the refund will be made in the payment form: cash/payment card.
  - If the product is returned later, but no later than 30 calendar days from the next day after purchase, the refund will be made to an OCHNIK gift card.
  - OCHNIK Customer Club members can return the product within 30 calendar days from the next day after purchase and receive a refund in the payment form: cash/payment card.
- **3.9.** A product purchased in the Promotion can be returned provided it has not been used and has the original tags attached. The proof of purchase must be attached to the returned product.
- **3.10.** Returns can be made at any regular OCHNIK store.
- **3.11.** In the case of returning a product that entitled the customer to receive a 10% discount on all products, the Promotion ceases to apply, and the customer is required to pay the price difference for the item originally discounted.

#### 4. Rules for Participation in the Promotion for Purchases in the X Online Store

- **4.1.** The 10% discount is calculated from the current sales prices.
- **4.2.** The discount is applied in the cart after adding products marked "Additional -10% on textiles and shoes" for a minimum of 149 PLN.
- **4.3.** Products purchased in the Promotion are subject to the general withdrawal rules applicable in the OCHNIK online store as specified in the Online Store Regulations.
- **4.4.** Returns of products purchased in the X online store as part of the Promotion should be made to the address: OCHNIK ONLINE STORE, 45c Przemysłowa Street, 08-410 Wola Rębkowska, Poland.
