



**REGULATIONS FOR THE PROMOTIONAL ACTION**  
**20% DISCOUNT WHEN PURCHASING A MINIMUM OF**  
**TWO NON-DISCOUNTED PRODUCTS FROM THE AUTUMN-WINTER 2024 COLLECTION**  
**(effective from 11.09.2024 to 16.09.2024)**

**1. General Provisions**

- 1.1.** The organizer of the "20% DISCOUNT WHEN PURCHASING A MINIMUM OF TWO NON-DISCOUNTED PRODUCTS FROM THE AUTUMN-WINTER 2024 COLLECTION" ("Promotion") is OCHNIK S.A. located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399

**2. Conditions and Rules of Participation in the Promotion**

- 2.1.** The promotion applies to regular OCHNIK stores and the online store <http://www.OCHNIK.uk>.
- 2.2.** The promotion does not apply to outlet stores.
- 2.3.** The promotion starts on 11.09.2024 and lasts until 16.09.2024 or until stocks last.

**3. Conditions and Rules of Participation in the Promotion**

- 3.1.** The promotion applies to non-discounted products from the AUTUMN-WINTER 2024 collection.
- 3.2.** To obtain a 20% discount, a purchase of at least two non-discounted products from the AUTUMN-WINTER 2024 collection must be made on a single receipt.
- 3.3.** The 20% discount is calculated from the current price of each product on the receipt.
- 3.4.** The promotion cannot be combined with other promotions or the 10% discount for OCHNIK Customer Club membership.
- 3.5.** Products purchased with the promotion discount can be exchanged within 30 days from the next day after purchase, provided they have not been used and have the original tags attached. Additionally, the receipt must be provided for the product being exchanged.
- 3.6.** The product exchange can be done at any regular OCHNIK store.



- 3.7.** After the promotion ends, products purchased with a 20% discount can be exchanged at the promotional price.
- 3.8.** Products purchased in physical stores under the promotion are subject to return under the following conditions:
  - If the product is returned within 7 calendar days from the next day after purchase, the refund will be issued in the form of payment: cash/payment card.
  - If the product is returned later but within a maximum of 30 calendar days from the next day after purchase, the refund will be issued on an OCHNIK gift card.
  - OCHNIK Customer Club members can return products within 30 calendar days from the next day after purchase and receive a refund in the form of payment: cash/payment card.
- 3.9.** The product purchased under the promotion can be returned provided it has not been used and has the original tags attached. The purchase receipt must be included with the returned product.
- 3.10.** The product return can be done at any regular OCHNIK store.
- 3.11.** In the case of returning a product that entitled the Customer to receive a 20% discount on all products, the Promotion ceases to apply, and the Customer is obliged to pay the price difference for the item originally discounted.

#### **4. Rules for Participating in the Promotion for Online Purchases at OCHNIK**

- 4.1.** The 20% discount at the online store [www.OCHNIK.uk](http://www.OCHNIK.uk) will be automatically applied in the cart after adding the products covered by the promotion.
- 4.2.** The value of the products will be reduced by the promotional discount.
- 4.3.** Products purchased under the promotion are subject to the general withdrawal rules applicable at the OCHNIK online store, as specified in the Online Store Regulations.
- 4.4.** Product returns purchased at the OCHNIK online store under the promotion should be made to the address: OCHNIK ONLINE STORE, 45c Przemysłowa Street, 08-410 Wola Rębkowska, Poland.
- 4.5.** In the case of withdrawal from the purchase of one of the products, the Customer is obliged to pay the difference between the regular price and the promotional price for the product they decide to keep.
