CCHNIK

REGULATIONS OF THE PROMOTIONAL CAMPAIGN ADDITIONAL -20% ON SUITCASES AND TRAVEL COSMETIC BAGS (effective from 01.08.2024 until further notice)

1. General Provisions

- 1.1. The organizer of the "ADDITIONAL -20% ON SUITCASES AND TRAVEL COSMETIC BAGS" ("Promotion") is OCHNIK S.A. located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399
- **1.2.** Under the Promotion, the Customer, when making purchases of at least 119 PLN, will receive a 20% discount on each suitcase or travel cosmetic bag.

2. Participants, Place, and Duration of the Promotion

- 2.1. Any natural person making purchases under the Promotion can participate.
- **2.2.** The Promotion includes regular stores, outlet stores, franchise stores OCHNIK, the online store www.ochnik.uk, and the OCHNIK store in Germany.
- 2.3. The Promotion starts on 01.08.2024 and lasts until further notice or while stocks last.

3. Terms and Conditions of Participation in the Promotion

- **3.1.** The Promotion applies to all suitcases and travel cosmetic bags.
- **3.2.** The 20% discount is calculated from the current price.
- **3.3.** To receive the 20% discount, a suitcase or travel cosmetic bag must be purchased for at least 119 PLN.
- **3.4.** The Promotion cannot be combined with other promotions or the 10% discount for OCHNIK Customer Club members.
- **3.5.** Products purchased with a discount from the Promotion can be exchanged within 30 days from the day after purchase, provided they have not been used and have the original tags attached. Additionally, a fiscal receipt must be attached to the exchanged product.

- **3.6.** The product can be exchanged in any OCHNIK stationary store. Products purchased in regular stores can only be exchanged in regular stores. Products purchased in outlet stores can only be exchanged in outlet stores.
- **3.7.** In case of exchange, the -20% discount only applies to products participating in the promotional campaign.
- **3.8.** After the Promotion ends, products purchased with a 20% discount can be exchanged at the promotional price.
- **3.9.** Products purchased under the Promotion in stationary stores can be returned under the following conditions:
 - If the product is returned within 7 calendar days from the day after purchase, the refund will be made in the form of payment: cash/card.
 - If the product is returned later but within a maximum of 30 calendar days from the day after purchase, the refund will be made on a OCHNIK gift card.
 - OCHNIK Customer Club members can return the product within 30 calendar days from the day after purchase and receive a refund in the form of payment: cash/card.
- **3.10.** The product purchased under the Promotion can be returned provided it has not been used and has the original tags attached. A proof of purchase must be attached to the returned product.
- **3.11.** The product can be returned in any OCHNIK stationary store. Products purchased in regular stores can only be returned in regular stores. Products purchased in outlet stores can only be returned in outlet stores.

4. Participation Rules in the Promotion for Online Store Purchases OCHNIK

- **4.1.** The 20% discount is calculated from the current sales prices.
- **4.2.** To receive the 20% discount, a suitcase or travel cosmetic bag must be purchased for at least 119 PLN.
- 4.3. The discount will be applied after entering the code: WALIZKI20 in the cart.
- **4.4.** Products purchased under the Promotion are subject to the general withdrawal rules applicable in the OCHNIK online store as specified in the Online Store Regulations.
- **4.5.** Products purchased in the OCHNIK online store under the Promotion must be returned to the address: OCHNIK ONLINE STORE, 45c Przemysłowa Street, 08-410 Wola Rębkowska, Poland.
