



**REGULATIONS OF THE PROMOTIONAL  
CAMPAIGN "ADDITIONAL 10% DISCOUNT ON  
LEATHER AND NON-LEATHER JACKETS"  
(WITH PURCHASES OF AT LEAST 149 PLN)**

**1. General Provisions**

- 1.1.** The organizer of the "Additional 10% Discount on Leather and Non-Leather Jackets with purchases of at least 149 PLN" promotion ("Promotion") is OCHNIK S.A. located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399.
- 1.2.** Customers who purchase a jacket for at least 149 PLN as part of the promotion will receive a 10% discount.

**2. Participants, Place, and Duration of the Promotion**

- 2.1.** Any natural person making purchases as part of the Promotion can participate.
- 2.2.** The Promotion applies to regular stores, outlet stores, the online store [www.ochnik.uk](http://www.ochnik.uk), and the OCHNIK store in Germany.
- 2.3.** The Promotion starts on 08.08.2024 and lasts until further notice.

**3. Terms and Conditions of Participation in the Promotion**

- 3.1.** The Promotion applies to all leather and non-leather jackets, excluding the new Fall-Winter 2024 collection.
- 3.2.** The discount is valid for purchases of jackets for at least 149 PLN and is calculated from the current price.
- 3.3.** The Promotion cannot be combined with other promotions or the 10% discount for OCHNIK Customer Club members. Products purchased with a 10% discount can be exchanged within 30 days from the day after purchase, provided they have not been used and have the original tags attached. Additionally, a fiscal receipt must be attached to the exchanged product.
- 3.4.** The product can be exchanged in any regular OCHNIK store.
- 3.5.** After the Promotion ends, products purchased with a 10% discount can be exchanged at the promotional price.
- 3.6.** Products purchased under the Promotion in stationary stores can be returned under the following conditions:



- If the product is returned within 7 calendar days from the day after purchase, the refund will be made in the form of payment: cash/card.
- If the product is returned later but within a maximum of 30 calendar days from the day after purchase, the refund will be made on an OCHNIK gift card.
- OCHNIK Customer Club members can return the product within 30 calendar days from the day after purchase and receive a refund in the form of payment: cash/card.

**3.7.** The product purchased under the Promotion can be returned provided it has not been used and has the original tags attached. A proof of purchase must be attached to the returned product.

**3.8.** The product can be returned in any regular OCHNIK store.

**3.9.** If a product that entitled the Customer to receive the 10% discount on all products is returned, the Promotion ceases to apply and the Customer is obliged to pay the difference in price for the items for which the discount was originally received.

#### **4. Rules for Participation in the Promotion for Online Store Purchases OCHNIK**

**4.1.** The Promotion applies to all leather and non-leather jackets, excluding the new Fall-Winter 2024 collection.

**4.2.** The discount is valid for purchases of jackets for at least 149 PLN and is calculated from the current price.

**4.3.** In the online store, the discount will be applied after entering the code: **KURTKI10** in the cart.

**4.4.** Products purchased under the Promotion are subject to the general withdrawal rules applicable in the OCHNIK online store as specified in the Online Store Regulations.

**4.5.** Products purchased in the OCHNIK online store under the Promotion must be returned to the address: OCHNIK ONLINE STORE, 45c Przemysłowa Street, 08-410 Wola Rębkowska, Poland.
