



PROMOTIONAL ACTION REGULATIONS
ADDITIONAL 20% DISCOUNT WHEN PURCHASING A MINIMUM OF THREE
SUITCASES/TRAVEL COSMETIC BAGS
(valid from 04.07.2024 until further notice)

1. General Provisions

- 1.1. The organizer of the "ADDITIONAL 20% DISCOUNT WHEN PURCHASING A MINIMUM OF THREE SUITCASES/TRAVEL COSMETIC BAGS" promotion ("Promotion") is **OCHNIK S.A.** located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399
- 1.2. As part of the Promotion, customers will receive a 20% discount on all suitcases/travel cosmetic bags when purchasing a minimum of three suitcases/travel cosmetic bags.

2. Participants, Place, and Duration of the Promotion

- 2.1. Any natural person making purchases within the Promotion can participate.
- 2.2. The Promotion covers regular stores, outlet stores, franchise stores of OCHNIK, and the online store www.OCHNIK.uk.
- 2.3. The Promotion starts on 04.07.2024 and lasts until further notice or while stocks last.

3. Conditions and Rules of Participation in the Promotion

- 3.1. The Promotion applies to travel suitcases and cosmetic bags.
- 3.2. To receive the 20% discount on suitcases, a purchase of at least three suitcases/travel cosmetic bags on one receipt at the price valid on that day is required.
- 3.3. The 20% discount is calculated from the current price.
- 3.4. The Promotion cannot be combined with other promotions or the 10% discount for OCHNIK Customer Club membership.
- 3.5. Products purchased with a discount from the Promotion can be exchanged within 30 days from the next day after purchase, provided they have not been used and have the original tags attached. Additionally, the fiscal receipt must be attached to the exchanged product.



- 3.6.** Product exchanges can be made at any OCHNIK stationary store. Products purchased in regular stores can only be exchanged in regular stores. Products purchased in outlet stores can only be exchanged in outlet stores.
- 3.7.** In case of an exchange, the 20% Promotion only covers products participating in the promotional action.
- 3.8.** After the Promotion ends, products purchased with a 20% discount can be exchanged at the promotional price.
- 3.9.** Products purchased in the Promotion at stationary stores can be returned under the following conditions:
 - If the product is returned within 7 calendar days from the next day after purchase, the refund will be made in the payment form: cash/payment card.
 - If the product is returned later, but no later than 30 calendar days from the next day after purchase, the refund will be made to an OCHNIK gift card.
 - OCHNIK Customer Club members can return the product within 30 calendar days from the next day after purchase and receive a refund in the payment form: cash/payment card.
- 3.10.** A product purchased in the Promotion can be returned provided it has not been used and has the original tags attached. The proof of purchase must be attached to the returned product.
- 3.11.** Returns can be made at any OCHNIK stationary store. Products purchased in regular stores can only be returned in regular stores.
- 3.12.** Products purchased in outlet stores can only be returned in outlet stores.
- 3.13.** In the case of purchasing three or more suitcases/travel cosmetic bags with a discount from the Promotion and then partially returning them, resulting in the receipt value falling below the required amount, the Promotion ceases to apply, and the customer must pay the price difference for the product that originally received the discount.

4. Rules for Participation in the Promotion for Purchases in the OCHNIK Online Store

- 4.1.** Ready sets of suitcases/cosmetic bags covered by the Promotion will be available in the "Luggage Sets" section. The prices of the presented sets of suitcases/cosmetic bags will include the 20% discount.
- 4.2.** Products purchased in the Promotion are subject to the general withdrawal rules applicable in the OCHNIK online store as specified in the Online Store Regulations.



- 4.3.** Returns of products purchased in the OCHNIK online store as part of the Promotion should be made to the address: OCHNIK ONLINE STORE, 45c Przemysłowa Street, 08-410 Wola Rębkowska, Poland.
- 4.4.** In the case of purchasing three or more suitcases/cosmetic bags with a discount from the Promotion and then partially returning them, resulting in the order value falling below the required amount, the Promotion ceases to apply, and the customer must pay the price difference for the product they decide to keep and for which they originally received the discount.
