PROMOTIONAL EVENT TERMS AND CONDITIONS

30% DISCOUNT ON NON-DISCOUNTED LEATHER GOODS WITH PURCHASES OF AT LEAST 79 PLN

(Effective from December 3, 2024, until further notice)

1. General Provisions

- 1.1. The organizer of the promotion "30% DISCOUNT ON NON-DISCOUNTED LEATHER GOODS WITH PURCHASES OF AT LEAST 79 PLN" (hereinafter referred to as the "Promotion") is OCHNIK S.A., headquartered in Garwolin, at ul. Stacyjna 8B, registered in the National Court Register under KRS number 0000604045, with VAT ID (NIP) 826-000-07-80 and REGON 005176379.
- **1.2.** As part of the Promotion, customers will receive a 30% discount on leather goods for purchases of at least 79 PLN.

2. Participants, Venue, and Promotion Duration

- **2.1.** The Promotion applies to regular OCHNIK stores and the online store at <u>www.ochnik.sk</u>.
- **2.2.** The Promotion begins on December 3, 2024, and continues until further notice or while supplies last.

3. Conditions and Rules for Participating in the Promotion

- 3.1. The Promotion applies to non-discounted leather goods.
- **3.2.** To receive the 30% discount, a purchase of leather goods worth at least 79 PLN is required.
- **3.3.** The Promotion cannot be combined with the 10% discount for OCHNIK Customer Club members.
- **3.4.** Products purchased with the Promotion discount can be exchanged within 30 days from the day after purchase, provided they have not been used and retain their original tags. A fiscal receipt must also be presented for exchanges.
- **3.5.** Exchanges can be made at any regular OCHNIK store.
- **3.6.** After the Promotion ends, products purchased at the promotional price are exchangeable at the promotional price.
- **3.7.** Products purchased in-store under the Promotion are subject to return under the following rules:
 - Returns made within 7 calendar days from the day after purchase will be refunded via the original payment method (cash/credit card).
 - Returns made after 7 days but within 30 calendar days from the day after purchase will be refunded via an OCHNIK gift card.
 - OCHNIK Customer Club members may return products within 30 calendar days from the day after purchase and receive a refund via the original payment method (cash/credit card).
 - Products purchased under the Promotion may be returned provided they are unused, retain their original tags, and are accompanied by a proof of purchase. Returns can be made at any regular OCHNIK store.

4. Rules for Participating in the Promotion for Online Purchases at OCHNIK

- **4.1.** Products covered by the Promotion will be marked with the designation "EXTRA30."
- **4.2.** To use the 30% discount on the online store <u>www.ochnik.sk</u>, customers must enter the discount code "EXTRA30" during checkout.
- 4.3. The discount will be applied in the cart to leather goods worth at least 79 PLN.
- **4.4.** The product's price will be reduced by the promotional discount.
- **4.5.** Products purchased under the Promotion are subject to the general terms of withdrawal outlined in the online store regulations.
