



**TERMS AND CONDITIONS OF THE PROMOTIONAL ACTION  
20% DISCOUNT FOR THE PURCHASE OF PRODUCTS NOT DISCOUNTED  
FROM THE AUTUMN-WINTER 2024 COLLECTION FOR A MINIMUM OF PLN 199 \*.  
(valid from 24.10.2024 until further notice)**

**1. General provisions**

- 1.1. The organiser of the action '20% DISCOUNT ON PURCHASE OF UNPRECEDENTED PRODUCTS AUTUMN-WINTER 2024 COLLECTION PRODUCTS FOR A MINIMUM OF 199 PLN' ('Promotion') is OCHNIK S.A. located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399.
- 1.2. Under the Promotion, a Customer who buys products from the AUTUMN-WINTER 2024 collection for a minimum of PLN 199 will receive a 20% discount on all products.

**2. Participants, place and duration of the Promotion**

- 2.1. The Promotion encompasses OCHNIK regular stores and the [www.ochnik.uk](http://www.ochnik.uk) internet shop.
- 2.2. The Promotion does not apply to outlet stores.
- 2.3. The Promotion starts on 24.10.2024 and lasts until recalled or until stocks last.

**3. Terms and conditions of participation in the Promotion**

- 3.1. The Promotion applies to non- discounted products from the Autumn-Winter 2024 collection.
- 3.2. The Promotion does not apply to the permanent collection.
- 3.3. The condition for obtaining the 20% discount is the purchase of products from the AUTUMN-WINTER 2024 collection for at least PLN 199 on one receipt.
- 3.4. The 20% discount is calculated from the current price.
- 3.5. The promotion does not combine with other promotions and a 10% discount for OCHNIK Customer Club membership.
- 3.6. The products purchased with a discount from the Promotion are subject to exchange within 30 days counted from the day following the purchase provided that they have not been used, have originally attached tags. In addition, a fiscal receipt must be attached to the exchanged product.
- 3.7. Replacement of a product can be done in any regular OCHNIK store.
- 3.8. After the end of the Promotion the products purchased with a 20% discount are subject to exchange at the promotional price.



- 3.9. Products purchased within the Promotion in stationary stores are subject to return according to the following rules:
- If the return of the product is made within 7 calendar days counted from the day following the purchase, the refund for the product in question will be made in the form of payment: cash/payment card.
  - If a product is returned later, but not later than within 30 calendar days counted from the day following the purchase, the money for the product will be refunded to the OCHNIK Gift Card.
  - Members of the OCHNIK Customer Club can return a product within 30 calendar days counted from the day following the purchase and receive a refund for the given product in a form of payment: cash/payment card.
- 3.10. A product purchased within the promotion may be returned provided it has not been used, has original tags attached. A proof of purchase must be attached to the returned product.
- 3.11. A product can be returned in any regular OCHNIK store.
- 3.12. In the case of returning a product which has entitled the Client to a 20% discount on all products, the Promotion ceases to apply and the Client is obliged to pay the difference in price to the item for which he/she originally received the discount.

#### **4. Rules of taking part in the Promotion in case of shopping in OCHNIK internet shop**

- 4.1. In order to take advantage of the 20% discount in the [www.ochnik.uk](http://www.ochnik.uk) internet shop you have to enter the discount code: EXTRA when finalising the transaction. Products covered by the promotion are marked in the product card: Use the code EXTRA and receive a 20% discount on non- discounted products from the Autumn/Winter 2024 collection
- 4.2. The value of the product will be reduced by the discount from the Promotion.
- 4.3. Products purchased within the Promotion are subject to general rules of withdrawal from the OCHNIK internet shop, specified in the Regulations of the internet shop.
- 4.4. The return of a product purchased in OCHNIK internet shop within the Promotion should be made to the following address: OCHNIK ONLINE STORE, 45c Przemysłowa Street, 08-410 Wola Rębkowska, Poland.
- 4.5. In case of renouncing the purchase of one of the products the Client is obliged to pay the difference between the regular price and the promotional price of the product he/she decides to keep.
