



**PROMOTIONAL ACTION REGULATIONS**  
**"BRIEFCASES, HANDBAGS, AND WALLETS ADDITIONAL -15% DISCOUNT**  
**For purchases of at least 169 PLN**

**1. General Provisions**

- 1.1. The organizer of the **"Briefcases, handbags, and wallets additional -15% discount for purchases of at least 169 PLN"** promotion ("Promotion") is **OCHNIK S.A.** located in the Garwolin, address: 8B Stacyjna Street, 08-400 Garwolin, Poland registered in the business registry maintained by the District Court for capital city Warsaw in Warsaw, XIV Economic Department of the National Court Register under KRS number 0000604045, NIP 826-000-07-80, REGON: 005176399
- 1.2. As part of the Promotion, customers purchasing briefcases, handbags, or wallets for a minimum of 169 PLN will be eligible for an additional 15% discount.
- 1.3. The Promotion cannot be combined with other promotions.

**2. Participants, Place, and Duration of the Promotion**

- 2.1. Any natural person making purchases within the Promotion can participate.
- 2.2. The Promotion includes regular stores and products in the online store [www.ochnik.uk](http://www.ochnik.uk) marked with the phrase **"Additional -15% on handbags, briefcases, bags, and wallets. The discount is applied in the cart for the above purchases"**.
- 2.3. The Promotion does not apply to outlet stores.
- 2.4. The Promotion starts on 04.07.2024 and lasts until further notice or while stocks last.

**3. Conditions and Rules for Participation in the Promotion**

- 3.1. The Promotion applies to all products from the following categories: handbags, briefcases, bags, and wallets. The Promotion does not apply to products from the Autumn-Winter 2024 season.
- 3.2. To receive the 15% discount, a purchase of products listed in point 3.1 for a minimum of 169 PLN on one receipt at the price valid on that day is required.
- 3.3. In the online store [www.ochnik.uk](http://www.ochnik.uk), products covered by the Promotion are marked with "Additional -15% on handbags, briefcases, bags, and wallets." The discount will be automatically applied in the cart.

- 3.4.** The discount from the Promotion cannot be combined with other promotions or discount coupons. The 10% discount for participating in the OCHNIK Customer Club and the discount from the current Promotion cannot be combined.
- 3.5.** Products purchased with a discount from the Promotion can be exchanged within 30 days from the next day after purchase, provided the product has not been used and has the original tags attached. Additionally, the fiscal receipt must be attached to the exchanged product.
- 3.6.** Product exchanges can be made at any stationary OCHNIK store. Products purchased in regular stores can only be exchanged in regular stores.
- 3.7.** In case of an exchange, the additional -15% discount Promotion covers only products participating in the promotional action.
- 3.8.** After the Promotion ends, products purchased with an additional -15% discount can be exchanged at the promotional price.
- 3.9.** Products purchased in the Promotion can be returned under the following conditions:
  - If the product is returned within 7 calendar days from the next day after purchase, the refund will be made in the payment form: cash/payment card.
  - If the product is returned later, but no later than 30 calendar days from the next day after purchase, the refund will be made to an OCHNIK gift card.
  - Products purchased with the additional -15% discount can be returned and exchanged according to the online store regulations available on the website: [www.ochnik.uk](http://www.ochnik.uk).
- 3.10.** A product purchased in the Promotion can be returned provided it has not been used and has the original tags attached. The proof of purchase must be attached to the returned product.
- 3.11.** Returns can be made at any stationary OCHNIK store. Products purchased in regular stores can only be returned in regular stores.
